Observation Index

The captured data provides seamless traceability to source documents. The Observation Index is configurable and customizable to facilitate classification and grouping of observations into well-defined categories. It also has the capability to identify duplicate and similar observations. The Observation Index is designed to integrate with CATS® as corrective actions are assigned to observations. Providing one source of truth for tracking the life cycle of an observation (identification, remediation, verification, and certification) is a key element of the Observation Index.

Regulatory Database

It correlates activities and resources required to complete corrective actions, enabling early identification of obstacles to critical path commitments. It employs multiple levels of security to ensure controlled access and has proven to be an effective tool for over ten (10) years.

The system integrates with CATS® and various Microsoft Applications. 
